Competitors must produce a valid and current CAMS Competition Licence and Club Membership Card of a CAMS-Affiliated Car Club and Log Book (if issued) at document check.

### **PRIZES & TROPHIES:**

Results shall be determined by Highest points of the day.

Event organisers reserve the right to cancel, abandon or postpone the event in accordance with NCR 59 of the current CAMS Manual.

Protests must be lodged in accordance with Part XII of the current CAMS Manual.

Each vehicle must comply with the current Observed Section Trials Car Formula as amended from time to time by the Austin 7 Club Inc. and as published in the current CAMS Manual of Motor Sport.

The event will be a club observed section trial which will be conducted under the authority of the International Sporting Code of the FIA, the National Competition Rules (NCR) of CAMS Ltd, the Observed Section Trials Formula, the CAMS Passenger in Vehicle guidelines (PIV), the Standing Supplementary Regulations - OST (SSR), these Supplementary Regulations (SR) and any Further Regulations (FR) or instructions that may be issued.

### **ALCOHOL, DRUGS AND OTHER SUBSTANCES**

Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.
